

CIMAM MEMBERSHIP GROUP COUNTRIES ALIGNED WITH ICOM

CIMAM aligns with ICOM's membership fee system and uses the same list of groups of countries which reflect different national economy's ability to contribute. These are defined according to the Gross Domestic Product (GDP) per capita by Purchasing Power Parity (PPP) of every State, as published by the International Monetary Fund for 2020 ([click here](#)) and in accordance with the annual average of monthly exchange rates as published by the Banque de France (€1 = USD1,117225). They are updated every three years and the last update was in 2017 for 2018.
